Scope

This policy is applicable to all Meenakshi Energy managed sites, licensees, outsourcing partners, corporate offices. This policy also applicable to all Meenakshi Energy employees, contractor employees, business partners, suppliers, and others with whom Meenakshi Energy does business.

In addition, this policy is applicable throughout the operational lifecycle of the projects. Furthermore, it extends to activities in our upstream and downstream value chain, limited to distribution, logistics, and sale of products and services to the customer.

Objectives of the Supplier Sustainability Management Policy

Meenakshi Energy Limited strives to:

- Proactively influence and encourage its suppliers to adopt sustainability practices including minimizing harm to the environment and society. This includes protecting biodiversity, efficiently using natural resources, and minimizing pollution.
- Ensure that our long-term suppliers adopt principles and practices in line with Meenakshi Energy Policies and Code of Conduct and comply with all local and national legal obligations.
- Ensure that the relationships with suppliers are conducted in a fair and transparent manner.
- Ensure that its suppliers take necessary actions to minimise risks associated with occupational hazards and prevent injury and ill-health to supply chain employees working at Meenakshi Energy operated and managed sites.
- Ensure that suppliers do not resort to any kind of forced or child labour, slavery and human trafficking at Meenakshi Energy operated and managed sites or at their own (supplier's) sites.
- Ensure that appropriate infrastructure and resources are made available to suppliers and their workers to carry out activities in sustainable manner while operating on Meenakshi Energy operated and managed sites. Ensure that appropriate and relevant information, instruction, and training are made available to suppliers and their workers on sustainability matters.
- Maintain effective supplier management systems and evaluate competence and sustainability performance prior to contract approval as well as throughout the contract duration.
- Carry out regular sustainability risk assessments and due diligence on the suppliers with intention to promote and align our suppliers with Meenakshi Energy Policies, ethical business practices and sustainability practices.
- Review performance against the policy on a periodic basis to ensure management of water as per our objectives including the sharing of good practices throughout the organization and stakeholders.
